	<p><b>c. Review of Technology Policy (2nd read) –</b> Approved by Consensus</p> <p><b>d. Furniture for Band Room –</b> Mr. Proctor addressed the committee to demonstrate the need for different chairs in the band room. He expressed that better chairs would help with both safety and Musicianship concerns. The amount of \$5658 would be shared 50/50 by council and the band account. This was approved by consensus.</p> <p><b>e. SBDM Election Bylaws –</b> Ms. Payne reviewed the bylaws specifically for teacher elections. She pointed out the portion of the bylaw that is not in compliance with the law. Ms. Payne informed the committee that SBDM teacher elections will continue with the exclusion of principal participation which is currently included in the bylaws. The bylaw will be corrected during a future meeting.</p>
